HUD Guidance

In the FY2016 HUD Continuum of Care (CoC) Program Competition NOFA, HUD provided the following guidance regarding the ranking of funding priorities:

- All projects, except CoC Planning applications, must be ranked in Tier 1 and Tier 2;
- Tier 1 is equal to 93% annual renewal demand (ARD), Tier 2 is equal to remaining 7% of the ARD plus any amount available for bonus projects, which is 5% of the Final Pro-Rata Need (FPRN);
- HUD will allow a project to straddle Tier 1 and Tier 2 (project will be partially awarded if Tier 2 portion is not funded);
- Tier 2 will be awarded by HUD based on a national comparison of project scores, using the following scoring guidelines:
 - Total Project Points Possible: 300
 - 200 Points possible based on the following sections of the CoC Application:
 - CoC Coordination and Engagement: 43 points
 - Project Ranking, Review and Capacity: 30 points
 - HMIS: 18 points
 - Point-in-Time Count: 9 points
 - System Performance: 40 points
 - Performance and Strategic Planning: 60 points
 - 100 Point Scale for Tier 2 Scoring based on the following:
 - CoC Score: 50 points
 - CoC Project Ranking: 35 points
 - Project Type: **5 points** for renewal and new permanent housing-permanent supportive housing and rapid rehousing, renewal safe haven, HMIS, SSO for centralized or coordinated assessment system, or transitional housing that exclusively serves homeless youth projects; **3 points** for renewal transitional housing, except those transitional housing projects that exclusively serve homeless youth; **1 point** for renewal SSO

project applications other than those for a centralized or coordinated assessment system

- Commitment to Policy Priorities: 10 points

For FY2016, CoCs are allowed to create new projects and bonus projects within the following parameters:

- New projects may be created through reallocation. Eligible project types include permanent supportive housing (PSH) for chronically homeless (CH) households, rapid rehousing (RRH) for individuals and families, supportive services only (SSO) for coordinated assessment, and Homeless Management Information System (HMIS) programs.
- CoCs may apply for up to 5% of the FPRN for PSH bonus projects serving CH households and/or RRH bonus projects. The Chicago FPRN at the time this document was created is estimated to be \$62,448,146. The bonus project amount is \$3,122,407. More than one bonus project is eligible to apply.

HEARTH FOTG Recommendations

The HEARTH FOTG reiterated the value of all program models in creating a strong CoC, and that any loss is a negative impact to the entire system. The HEARTH FOTG reviewed the HUD ranking guidance, past ranking policies, system priorities, and various other factors and recommends the following ranking order for the HUD CoC-funded projects for FY2016:

Considerations for HEARTH FOTG Ranking Recommendations

The HEARTH FOTG met six times between July 12 and August 9, 2016, to identify recommendations for the FY2016 Ranking Policies. In order to make these determinations, the HEARTH FOTG considered several factors, including local evaluation instrument scores, project types, vulnerability of target populations (including chronic homelessness, unaccompanied youth, families, physical and mental health barriers, and substance use barriers), the number of family and individual units and unit location. The HEARTH FOTG considered each of these factors in relation to Chicago’s Plan 2.0 to End Homelessness and HUD guidance.

Renewal Project Ranking

For Tier 1, the HEARTH FOTG decided not to prioritize one program model over another, as each plays an important role within the CoC; therefore, the HEARTH FOTG decided to recommend ranking programs based on local Evaluation Instrument scores. The average of the last two years (2016 and 2015) were used for determining ranking.

All renewal projects that fell into Tier 2 were PSH projects scoring an average of 63% or lower with the exception of one renewal project scoring slightly above 64%.

Reallocation

The HEARTH FOTG considered multiple scenarios regarding creating new projects through reallocation. Consideration was given to the impact of reallocation on renewal projects, the types of new projects eligible to be created through reallocation, community need, and HUD guidance. The HEARTH FOTG decided to reallocate 20% of one low-scoring PSH project based on 2015 and 2016 Evaluation Instrument scores and 100% of one PSH project not meeting the Evaluation Instrument deadline threshold. At the July 25, 2016 Chicago CoC Board of Directors meeting the reallocation recommendations were reviewed by the CoC Board. The Board upheld the HEARTH FOTG's recommendations with the exception of reallocating 100% of the low scoring project instead of just 20% of the grant amount.

The final amount of reallocation will be \$601,071. \$254,651 is being reallocated to creating a new Coordinated Assessment SSO project for the CoC and a new PSH project will receive \$346,420 in reallocated funds.

The HEARTH FOTG decided to place the new CA SSO completely in Tier 1. The reallocated PSH project was chosen as the "straddle" project between Tier 1 and Tier 2. The project will be scaled back if the Tier 2 portion is not funded.

HMIS and Coordinated Assessment SSO Ranking

The HEARTH FOTG determined that the HMIS and Coordinated Assessment grants (two renewals and one new project through reallocation) provide critical resources to improve the capacity of the Chicago CoC to effect system change. The HEARTH FOTG decided to recommend placing these projects at the top of Tier 1.

Bonus Projects

The HEARTH FOTG determined that bonus projects for PSH for Chronically Homeless households or rapid rehousing be allowed to apply for up to \$3,122,407 in the FY2016 HUD CoC Program Competition. This recommendation was passed by the Chicago CoC Board of Directors at its July 25, 2016 Board Meeting.

The HEARTH FOTG decided to place the Bonus Projects in Tier 2 behind the straddle project and one PSH renewal scoring above 64%.
