David currently participates on the Coordinated Access Steering Committee, CRS Managing Entity Advisory Board, Co-Chair of the Service Providers Commission, and Representative of the SPCEC on the Planning Council. Other Chicago homeless community involvement David participated as a part of the lead team in the 100,000 Homes Rapid Results Campaign.**

**In addition to his Chicago CoC participation, David is an Executive member of the Supportive Housing Providers Association (SHPA) and the Illinois Inter-agency Council on Ending Chronic Homelessness.**
